

Environmental Education Intern

Wildlands Conservancy is the premier nonprofit land trust of the Lehigh Valley and Lehigh River Watershed. In this role, you will:

- Grow with guidance from our experienced directors and seasoned staff to assist in the presentation of a vast array of hands-on, nature-based programming. This will include summer camp on our 4 site locations (Dorothy Rider Pool Wildlife Sanctuary (DRPWS), Emmaus; Parks in Upper Saucon, Upper and Lower Macungie Townships; and a vast number of community group presentations at DRPWS or anywhere in the Lehigh River watershed.
- Collaborate in designing and completing an internship project benefiting both you and Wildlands
 Conservancy. Projects may include curriculum development, designing education materials
 connected to your major, or something uniquely yours.
- Grow leadership skills as part of a supervisory team guiding children in decision-making, behavior management, and living ethics.
- Work harmoniously in manifestly friendly but close quarters.
- Work occasional nights and weekends, tolerance of inclement weather is also required.
- Have latitude to coordinate your internship schedule with other commitments.
- Participate in a project with our Conservation Department at DRPWS or another <u>Wildlands</u>
 <u>Conservancy Preserve</u>. Projects focus on habitat/trail restoration, preservation and enhancement, and stream conservation.
- Possibly transition into a paid position when internship hours are completed.

To be successful you will need:

- Completion of at least one year towards a BS or BA and commitment to educating the public through science-based hands-on learning.
- Experience teaching environmental education preferred, but not mandatory.
- To be comfortable speaking in front of a group and interacting with people of all ages, income levels, cultural backgrounds, and intellectual abilities.
- Ability to work independently and within a team.
- A strong work ethic and sense of humor.
- Ability to lift up to 25 pounds.
- Basic computer literacy in Microsoft Office.
- Excellent interpersonal skills.

- A professional appearance.
- To possess or be willing to obtain; current CPR, First Aid, and AED certification; Pennsylvania Child Abuse History Clearance (Act 151); Pennsylvania State Police Request for Criminal Record Check (Act 34); FBI Clearance (Act 114)
- A valid Pennsylvania Driver's License.

Working conditions

Wildlands Conservancy offices are smoke-free. The ability to work harmoniously in manifestly friendly – but close – quarters is required. Occasionally working long and unusual hours, including some evenings and weekends, and walking and standing on uneven natural surfaces on land or in water is common. Travel is usually local, rarely requiring overnight stays, and in most cases provided by Wildlands Conservancy.
